Dear Vendor Applicant,

Thank you for your interest in being a vendor. We have experienced some changes over the past couple years. We appreciate your patience as we do our best to continue this yearly event.

If possible, we'll open the park for vendors **paying for two days** on late Thursday. Please check the website for any last minute changes at www.pleasantvalleydays.com.

Remember there is no electricity in the park field, however there are a **LIMITED** number of outlets available for an extra charge of \$25.00. You will need a minimum of a HEAVY-DUTY 12 gauge extension cord and arrangements **must** be made **before** the event and fees are paid. We are not responsible for planning your electrical needs. Your additional fee buys you **ONE 15 AMP CIRCUIT**. Please plan accordingly. If staff determines you are using more than a 15 amp service you will be charged an additional fee of \$50, or immediately disconnected.

There are NO TRAILERS, VEHICLES or RVs allowed to stay inside the park and **NO CAMPING inside the park**. There **IS** an RV park adjoining the vendor area, ideal for staying near your booth. For reservations and availability please contact the South Shore Snack and Pack at 435-448-9697. On a case by case basis, you may possibly be allowed to stay inside your booth overnight with permission from the vendor manager.

There is NO overnight security in the park. Scofield Town and Pleasant Valley Days will not be held responsible for loss or damage of ANY kind.

INSTRUCTIONS:

1. Your application, along with fees must be submitted no later than Monday, June 26, 2017.
2. Booth fees are \$75.00 for Saturday only, or \$100 for Friday & Saturday.
3. Check-in time available on Thursday between 4—6pm, or Friday between 8am and NOON. Saturday-only vendors must be inside the park and set up no later than 9am. NO VEHICLES are allowed inside the park on Saturday! NO EXCEPTIONS.
4. NO refunds or cancellations after June 26th.
5. **YOU are responsible for disposing of your own garbage. A DUMPSTER is provided OUTSIDE the park grounds. DO NOT place garbage in the park garbage cans.**
6. Alcohol consumption by vendor or agents is strictly prohibited.
7. You are responsible to bring all the supplies and equipment you will need. No assistance is available.
